

## INVITATION TO BID

The Housing Authority of the County of Blair (the Housing Authority) will receive sealed bids for **Fund Program – PA28PO69501-17 – Parking Lot Sealcoat Installation Projects** for Bell Court located in Bellwood, PA and Cold Springs located in Snyder Township until 10:00 a.m. local prevailing time on **Friday, October 5, 2018**, at the Housing Authority of the County of Blair's Administrative Office, 1407 Blair Street, Suite #4 Hollidaysburg, PA 16648, at which time and place the Bids will be publicly opened and read aloud for the General Construction contract for the project. Bids must be sealed and shall be marked as follows:

**Fund Program – PA28PO69501-17**  
**Parking Lot Sealcoat Installation Projects – Bell Court and Cold Springs**  
**Bid Documents – General Construction**

The name and address of the Contractor submitting the bid should also be clearly labeled on the outside of the bid envelope.

Project consists of seal coating of the parking lots at Bell Court, 1311 North Cambria Street, Bellwood, PA and Cold Springs, 105 Cranberry Street, Tyrone, PA (Snyder Township), Blair County, Pennsylvania. The Prime Contract shall consist of:

Contract No. GC-1: General Construction Work.

Bids must be on a combined lump-sum basis; separate Bids for individual trades will not be accepted. Project is to be substantially completed within 45 calendar days from the date of award of Contract. This contract is federally assisted. The Contractor must comply with the Davis-Bacon Act.

A complete set of Bidding Documents may be reviewed and obtained at the office of the Consultant, Stiffler – McGraw and Associates at the Hollidaysburg Office – 1731 N. Juniata Street, Hollidaysburg, PA 16648 beginning on **September 20, 2018**. Only a Contractor obtaining Bid Documents from the Consultant will be considered to be a registered bidder.

The Bidding Documents are available for purchase by Prime Contract Bidders for the non-refundable sum of \$25.00 or a digital set of bidding documents are available in pdf format for the sum of \$12.50 per CD with all checks made payable to "Stiffler – McGraw and Associates". Incomplete sets of Bidding Documents will not be issued. A non-refundable postage and handling charge of \$10.00 per printed set and \$5.00 per CD will be added for each set or CD that is mailed to Bidders. Payment must be received before documents will be released. The Housing Authority and Consultant assume no responsibility for delay or loss due to mailing.

A non-mandatory Pre-Bid Conference and Project Review will be held to answer questions on Scope of Work, and to familiarize bidders with existing conditions, site location, and other relevant information. Conference will be held at the Bell Court project site, **1311 North Cambria Street, Bellwood, PA** at 9:00 a.m. local prevailing time on **Wednesday, September 26, 2018**. Following review of this site attendees can also view the second project site at Cold Springs, 105 Cranberry Street, Tyrone, PA (Snyder Township).

A certified check or bank draft, made payable to the order of "Housing Authority of the County of Blair", U.S. Government Bonds, or a satisfactory Bid Security (Bid Bond) executed by the Bidder and an acceptable surety, in the amount equal to ten percent (10%) of the total Bid, must accompany the Bid in accordance with the Instruction To Bidders. No Bid Surety shall be waived or returned because the Bidder has failed or cannot comply with any requirements set forth in the plans, specifications or any applicable statutes of the Commonwealth of Pennsylvania or any applicable municipal ordinances. A Bid may not be modified, withdrawn or cancelled by the Bidder within sixty (60) calendar days following the time and date designated for

the receipt of Bids, without the written consent of the Housing Authority. The surety must be a Guarantee or a Surety Company acceptable to the U.S. Government as published in the U.S. Treasury Circular No.576 and must be licensed to do business in the Commonwealth of Pennsylvania.

The successful Bidder will be required to furnish and pay for an assurance of completion of project in the form of Payment and Performance Bonds, each in the amount of 100% of the Contract Price; a cash escrow in the amount of twenty percent (20%) of the Contract Price; or an irrevocable letter of credit in the amount of twenty five percent (25%) of the Contract Price.

Attention is called to all Bidders that all applicable Equal Employment Opportunity requirements for federally-assisted construction contracts must be complied with. This includes strict compliance with Executive Order 11246, as amended (establishing a goal of 6.9% for female employment and 1.3% minority percentage by craft); Nondiscrimination; Executive Order 11625, Minority Business Enterprise; Executive Order 12138, Women Business Enterprise; Section 3 of the Housing and Urban Development Act of 1968; Civil Rights Act of 1964; Minority Business Participation; and HUD Wage Rate Determination.

Notice is hereby given that this is a Section 3 covered project and that the area has been defined as a Section 3 area. The Housing Authority promotes the utilization of business concerns which are located in or owned in substantial part by persons residing in the Section 3 area and promotes job training and employment opportunities for qualified, lower income, Section 3 area residents.

Registration in the System for Award Management (SAM) database will be required for Award.

The Housing Authority of the County of Blair reserves the right to waive irregularities and to reject Bids.
